The candidates so appointed, if he/her or any of his/her family members is availing benefits under the Orunodoi Scheme at the time of appointment, he/she or the concerned family member shall voluntarily opt out of the Scheme, as per Orunodoi guidelines for getting appointment to the post.

The candidate so appointed if found to have furnished false/falsified information regarding educational qualification/caste/gender/EWS status, etc. in his/her application and detected subsequently, will be terminated and legal action will also be taken as per law.
